Minutes of 2019: Minutes of the 2019 AGM were accepted unanimously.

Report Summaries:

Peter summarised his comments from his published report - he thanked everyone for their commitment and whilst the Association has some challenging days ahead, it enjoys widespread support and commitment which will inevitably see it through to the better times to come.

England Captain:

Curt had to depart the meeting and was unable to present his report - that said, given no matches had taken place, it was only likely to concern future selection and fixtures.

Mark Trafford suggested that it may be the case that the England team selected last year would be unchanged for any 2021 events - this will require confirmation from Curt and the England Selection Committee.

Secretary:

Lorin set out his outstanding actions as follows:

- Handover of website, handover of WordPress management and management of association email accounts to Nigel Senior
- Handover of AEBBA Paypal account for online entries to Gerry Fitzjohn Lorin clarified how the charges are applied and how this has been covered to date
- Handover of secretary@ email account to successor
- Most of the AEBBA display and merchandising assets are already on the van 2x banner stands, 1x 'pop-up' artwork, 2x tablecloths. Remaining assets (1x 'pop-up' artwork, remaining branded pens, branded tape measures, branded mints will be posted to successor in the coming days.

Treasurer: Gerry said that he agreed with most of the findings in the Verifier's statement. The balance in the AEBBA account is £2,509.08 down on the the closing balance of last year - this is in large part due to the reduction of table hire revenues (some £3,600) but it is clear that there has been a lack of expenses too as a result of the lack of events.

Gerry is eager to introduce budgets for events and other expenditure in order to improve good financial practice in line with Chris Saville's recommendations. Peter confirmed that the committee will develop a clear strategy before the end of 2020. A plan will be developed to ensure adequate funding is in place in order to replace the van in 3 years time (if required). Gerry will also review the table maintenance program currently undertaken by Matt Jones.

Matthew Knight asked whether any monies are owed on the van - Gerry confirmed that it is completed owned by the association and that AEBBA carries no debt. Mark Trafford asked whether the association had investigated the possibility of a government grant to mitigate some of the losses - Gerry agreed to investigate and report back before the end of the calendar year.

Gerry recommended that there be no change to county affiliation fees - Peter noted the recommendation and marked for discussion later in the meeting.

Chris Saville added that he believed many of the bad practices of the last two or three years would be resolved moving forward and so recommended that the accounts be accepted.



Also thanks to Nigel Senior not for providing statistics and ranking points but providing the virtual competitions despite the fantasy results, it probably kept some of us sane.


Lastly thanks to all those who have supported the association through good times and bad, please stay safe and I look forward to being beaten by you next time we play..

The minutes of the 2019 AGM were published on the Association's website on 22nd December 2019 and have been available for review at this address:



A NEW NORMAL? A NEW DIRECTION!

Some changes are chosen and some are enforced. The last three years has seen many changes for those of us close the the A.E.B.B.A - many of them we chose. However, nobody would have chosen what has happened to the world in the last nine months - and the knock-on effect on our operations and way of life has been significant.

Before anything else, I'd like to take this opportunity to praise all of the Key Workers and helpers in our Bar Billiards Community who have gone the extra mile and taken countless risks in order to keep the nation ticking along and to keep the people safe, fed and healthy. Thank you. When we needed you, you were there - nobody could have expected everything you delivered - you are heroes.

The impact on Bar Billiards nationally has been devastating and there will be many changes required before all of our community feels able to participate once more. Changes that will be difficult, changes that may be unpopular but - like those we have chosen in the last three years, changes that are absolutely necessary.

I am fully aware that change is difficult for many - in my time as Secretary of the association I have received tremendous volumes of feedback about the changes we have implemented. Feedback that has covered a full spectrum of satisfaction levels and opinions. The destination is sometimes more important than every step of the journey - I am grateful to those who felt able to listen and to understand that. I believe passionately that everyone should have the chance to present their views - and I have always been committed to seek to ensure all views are considered.

It is possible that there has not been as important an AGM than this for perhaps a decade or more - the association will need the full support of every affiliate county, every competition participant and every voice from the sidelines if it is to successfully navigate the choppy waters ahead.

The agenda over the coming months will be dominated by how to successfully resume play, how the association can provide additional support to affiliated counties and how to minimise the long-term impacts of COVID-19 and economic hardships on our playing community.

I also believe that the modernisation of the association, the relentless focus on improvement and the desire to increase participation for all should not be lost during this time. I remain of the view that the association is in a healthy position to help and support others and to weather this storm.

I have also been convinced for some time that I am not the best person to lead the association - my approach, my desire for change and my 'style' has not been easy for many to come to terms with and that is why I believe the association will be better served if I stand aside to enable others with very strong views and ideas to lead the way of the coming years.



I am proud of many of the changes we implemented, highest among them being the Challenger Championships - the first real effort by the association in many years to be inclusive and to promote play more widely around the country. There are others which I'm thrilled about and others still which I feel could have been better thought through - I wouldn't be being honest with myself if I didn't think improvements could have been made!

None of this would have been in any way possible without the support of a fantastic committee, the tireless work from many including Kevin Tunstall, Pete Sainsbury, Curt Driver, Gerry Fitzjohn, Chrissie Newson, Chris Saville, Nigel Senior, Matt Jones, Dennis Atkins and many others. The future of Bar Billiards can look very bright when you consider the fantastic commitment these people provide - it's great to know that Bar Billiards has such a great community watching its back!

Most importantly, by some distance, I'd like to thank Dave Alder for his constant support and counsel - I have enjoyed much about my time with the A.E.B.B.A. but nothing more than the times Dave and I set up events and the laughs we have shared on the admin desk. I will treasure memories like that.

Finally, I'd like to congratulate the new Secretary on their appointment and wish them every success in the role.

ACCOUNTS VERIFICATION STATEMENT - CHRIS SAVILLE

On Monday 7th September I was invited to verify the accounts for 2019- 2020. This left very little time which is understandable as the AGM had been pulled forward to thirteen days after the accounting period closed due to the truncated season.

Basically, my comments mirror those of Paul Sainsbury who verified the accounts last year. This is hardly surprising as the belated appearance of last year's accounts and coronavirus mean that this year's accounts had effectively closed when last year's were verified. Thus there was no time to act upon Paul's comments apart from Bournemouth for which I produced the accounts.

The comments from Paul on last year's were:

- Missing invoices particularly one for £982 van MOT.
- Level and accountability of prize monies.
- Bournemouth 2019 needed to be itemized to show a proper profit/loss.
- Paul was unable to verify the invoices and payments from the AEBBA competitions because of a combined payin, covering some thirteen competitions, in the time available.

The same applies this year except Bournemouth:

- Not all invoices were available to view and some expenditure could not be explained even with an invoice.
- All AEBBA competitions prize monies were paid out of petty cash and so unaccountable once again.
- Comments were acted upon for Bournemouth and prizes were paid by cheque and so could be verified. Bournemouth account was fully
 itemized with a profit/loss.
- The AEBBA comps could not easily be separated financially and most
 monies paid out of petty cash without an audit trail so verification has not been fully completed.
 The current Treasurer has been very helpful this week during a period when other problems have limited the amount of time I could spend on the accounts.

ACCOUNTS VERIFICATION STATEMENT - (CONT)

As a past Treasurer and still an account holder, I have an excellent knowledge of the accounts and the expected payments. Thus to save time I have only sample checked the invoices as I anticipate no questionable payment values.

My job is to verify the accounts not to comment on financial aspects of the year's severe trading loss but I would hope that is looked at in detail by the AEBBA committee and 2020-21 budgeted for before the bills start rolling in. Sponsorship could well be far less than we were fortunate to receive over the previous two years.

I thus recommend acceptance of these accounts to the AGM.

For the coming year the enforced break means that AEBBA have the perfect opportunity to look at their accounting practices. I would recommend as verifier:

- All transactions, where possible, go through the account.
- Invoices be paid out of the account, not using petty cash as it bypasses the secure dual signature authorisation system
- All receipts be paid into the account in a timely fashion, not months later.
- The AEBBA committee look at issuing a debit card to the tables' delivery manager so that truck expenses are better controlled, invoices still to be collected though.
- The AEBBA competition finances must be completed for each competition immediately after it takes place.
- The multiple methods of collecting entry fees for the AEBBA comps caused errors in the accounts last year and much confusion and conversation with the Treasurer this year! I am not happy about the concept of an individual accepting entry fees for AEBBA comps by web payments into an account that is not controlled or verified by AEBBA.

Peter stated that he will confirm with Curt and Tony Cross that they wished to continue as co-opted members of the committee. Confirmation was received from Stephen Coleman that he will stand down from the committee. Mark Trafford stated that he is willing to be a co-opted member of the committee.

Peter added that the loss of Dave Alder from the association is the most significant change in many years and the volume of thanks given to Dave will never match his contribution. He hoped that in 2021 a proposal would be brought ton make Dave an Honorary Life Vice-President of the association.

Jean asked to clarify the role of Delivery Manager and how this would be dealt with. Lorin explained the premise behind the role and that it was intended to find a suitable candidate to fill this function prior to the COVID-19 outbreak but that this had become impossible. This represents a significant challenge to the association's operations. Peter confirmed that the committee will develop a plan before the end of the calendar year.

PROPOSALS TO THE AGM

PROPOSAL 1 (Amendment to Rule 88):

In our league, a significant fraction of our players are new to the game, and occasionally when reading the rules, misunderstandings occur. One such misunderstanding is on the rule regarding the last ball shot. It's clear to me personally that the intention of the rule is that the only cushion the ball may hit is a side cushion, however it can also be interpreted that the ball may hit the back cushion, so long as it doesn't go down any of the holes. This rule change is a wholly cosmetic one to make clear that the ball may only strike one side cushion. The asterisks added are just for emphasis, and should not be included in the text of the rule.

If only one ball remains, either in the rack or on the table, the break score should be recorded before the last shot is played. The last ball must then be played from the centre of the "D" into either the 100 or the 200 hole, ***off exactly one cushion, which must be a side cushion.*** This is known as the 'Last ball shot'. Before playing the last ball shot the white skittles should be placed in the 50 holes and the top holes guarded. If the ball strikes a skittle in the 50 hole, and falls into the 100 or 200 hole, the score will not count. Both players should continue to play the last ball shot alternately until the ball is potted or the black peg is knocked down.

DISCUSSION ON RESUMPTION OF PLAY

Peter stated that, given the association has no jurisdiction over leagues around the country, it is not possible or approbate to issue guidelines for the safe resumption of play.

Chris Saville added that the advice from DCMS and other government agencies is not entirely clear but that 'three players per team' matches should be possible.

Mark Trafford asserted that AEBBA is not a governing body and therefore should not seek to provide national guidance. Peter agreed that this mirrors the view of the association. Nevertheless, the association will be on hold to support local leagues with advice and recommendations where sought.

Peter added that it is likely that Bournemouth 2021 wold be the association's next tournament followed by planning for the standard Autumn schedule.

Lorin clarifies that this means the cancellation of the 2020 All England Individual Championships - this was agreed and accepted.

ANY OTHER BUSINESS

AOB items discussed:

Bournemouth 2021: Michelle Baden set out that she had met with a number of hotel options for 2021 and the recommendation is to book with The Cumberland Hotel. The hotel has 117 rooms available and will not book any rooms for out of party if the association books 100 rooms. The fees proposed are as follows:

Friday-Sunday DBB: £115 per person

The hotel will offer reduced bar prices broadly in line with The Queens Hotel

The hotel has committed to commensurate tournament sponsorship prizes and no charge for tournament event rooms. Evening entertainment will not be included and must be charged by the association to guests.



There will be no additional charges for single subsidy but an additional charge for sea-view rooms of approx. £10 per person.

Lorin asked whether the hotel expect a minimum order of rooms and Michelle confirmed that they had agreed no minimum order and so no liability to the association. Mark Trafford sought to clarify if rates are available for B&B only - Michelle confirmed she will ask and feed back.
